A few items of information for you or your association newsletter:

<u>The Board Corner: Perspectives from Penny</u> – September heralds many new beginnings, as students in Fairfax County embark on a new school year. For the kindergartner or first-grader, taking the big yellow bus to school may be the first real and exciting transition in a young life. For high school students, taking the bus may be a last resort as they anxiously await the responsibility of a drivers' license and the possibility of driving themselves to school.

In any case, safety should be paramount, whether riding the bus or walking to classes. Drivers are reminded that passing a school bus when its red lights are flashing can result in a reckless driving ticket, including \$2500 in fines, loss of your license for six months, and/or 180 days in jail. All drivers must stop when a school bus is loading or unloading (identified by the flashing red lights), unless there is a raised median or wall between the travel lane and the stopped school bus. Most of our residential streets do not have raised medians or walls so, in nearly every case where a school bus is stopped, you should assume that the red lights are about to

start, and be ready to stop. Please pay attention, too, to school zones marked with "25 MPH" flashing signs called Wink-o-Matics. The lights are activated to flash 30 minutes before school starts, and for 30 minutes after class dismissal. Speeding through a Wink-o-Matic sign can result in a ticket, higher fines, and increased points against your license.

Morning and afternoon traffic around schools also may increase this month, as parents and students become accustomed to the schedules and rhythms of a new school year. If your commute takes you past a school, please exercise additional caution and patience. Everyone – drivers, students, and teachers – wants to get to their destination safely. Let's make sure they do.

Little River Turnpike Bicycle Corridor Study – Fairfax County is planning to improve conditions for bicyclists and pedestrians along Little River Turnpike. The Board of Supervisors allocated \$7.5 million to make the corridor safer and more inviting for people to walk and bike. The study kicked off in early 2016 and, with the help of community input, is heading toward completion. The goal of the study is to recommend short-term projects for implementation, and long-term recommendations for the corridor that are missing from the current bicycle master plan. The **final meeting of the study**, which will include the recommended projects, will be held on **Friday**, **September 26**, **2016** from 6:30-8:30 p.m. in the cafeteria at Annandale High School, 4700 Medford Drive in Annandale. <u>Redevelopment of 5600 Columbia Pike Planned</u> – Novus Property Holding LLC has proposed to repurpose the vacant office building located at the intersection of Columbia Pike and Carlin Springs Road near the Fairfax/Arlington County border. The applicant offers an E-Loft concept where the tenant can choose to live, work, or do a combination of both, in their unit. Upon approval of a zoning application, Novus plans to renovate and convert the 10-story 166,000 square foot building into 157 loft units at roughly 1,000 square feet per unit. This would be the second E-Loft building in the region after the alteration of a vacant office building in Alexandria just off King Street near Shirlington. A schedule of public meetings about the proposal will be announced soon.

<u>Study for Lincolnia Comprehensive Plan to Begin this Fall</u> – The Lincolnia Planning District Land Use Study will commence this fall to consider designating a portion of Lincolnia as a Community Business Center (CBC) within the Fairfax County Comprehensive Plan. Based on its outcome, the study will provide planning guidance, particularly land use and development intensity recommendations. The study also will provide review and updated planning guidance for the entire Lincolnia Planning District. A citizen task force will lead the community participation and guide the study. Graham Park Plaza Plan Amendment Advances to Next Step – On January 27, 2015, the Board of Supervisors authorized the consideration of a Comprehensive Plan amendment for Graham Park Plaza, formerly Loehmann's Plaza in the Jefferson Planning District. The current adopted Plan for this area recommends community-serving retail uses. The Board requested that county staff consider a mix of residential and nonresidential uses. Additionally, Plan analysis should provide attention to transportation, while planning for high-quality design for the shopping center. On **Tuesday, September 27, 2016**, county staff will present the draft Plan text to the Mason District Land Use Committee. The meeting will take place at the Mason District Governmental Center, 6507 Columbia Pike in Annandale, beginning at 7:30 p.m. The Plan Amendment also has public hearings before the Planning Commission scheduled for **Thursday, October 20 at 8:15 p.m.**, and before the Board of Supervisors on **Tuesday, December 6 at 4 p.m.**

<u>The Quick 411</u> – Is it o.k. to feed geese? **Our wildlife officials urge residents to stop feeding geese**. In addition to health and environmental consequences, geese rapidly can become dependent on human-provided foods. Much of what we use to feed geese (bread, corn, popcorn, pastries, etc.) provides little or no nutritional value, and can cause significant health problems for geese and other wildlife. Left on their own, geese will feed on a variety of nutritious foods that are available (e.g., grasses, sedges, berries, grains and seeds) and will move to new locations when resources have been depleted.
