CRIME PREVENTION – everyone's responsibility

We recently had several cars burglarized in Leewood. Statistics show that a burglar or vandal will work where they will be undetected. They seek out the darkest neighborhoods with the easiest targets, opportunity and places to hide. The Fairfax County Police Department says at the very least; keep your home lit in the front and back at dark. All it takes to make our neighborhood less inviting to a burglar is a little common sense and several easy, effective and inexpensive crime prevention measures.

Tips to Prevent Burglaries



Get involved so we can have a safer neighborhood. Get to know your neighbors, and talk to them often. You can make a difference!



Here are a few thoughts about how you can decrease your chances of becoming a burglary victim:

- Lock all doors and windows, even upstairs.
- Get a monitored alarm system.
- Keep bushes or hedges trimmed away from windows.
- Close your curtains or blinds when the house is empty.
- Use timers to turn lights or radios on and off while you're gone.
- Notify a neighbor you trust when you will be away from home.
- Keep outside front and back lights on at dark.
- Don't talk about out-of-town trips in front of strangers.
- Don't let mail, flyers or papers pile up when you're out of town.
- Change your routine. Don't go to the store, bank, library, etc. at the same time every day.
- Record serial numbers and take pictures of valuables.
- Lock and alarm your car or use a club.
- Keep all credit card account numbers and customer service numbers handy in case your wallet/purse is stolen.
- Get to know your neighbors. Watch out for each other!
- Report suspicious activity.

Identity Theft – *a growing problem*

Identity Theft occurs when an unauthorized person uses your name, date of birth, social security number, etc. to obtain credit without your consent. These offenses are very difficult to pursue and specific financial documentation required can only be obtained by the crime victim. It is suggested that you take the following steps to prevent someone from stealing your identity.

Review Before Signing - Always add up your charge slip before signing it. Draw lines through blank areas. Never sign a blank charge slip.

Save Receipts - Receipts are proof of your purchases and transactions. They are invaluable in the event of a dispute. Keep your debit or credit card receipts.

Check Your Accounts Frequently - With credit card fraud on the rise, check your credit card and debit accounts often. Don't wait to review your statement at the end of the month. Call your bank or check your account on line regularly.

Check Your Monthly Statement - Check your monthly billing statement carefully to see if it includes transactions or purchases you did not authorize. Compare your receipts to the billing statement. Be on guard for dishonest merchants who might change your receipt after you sign it. You are especially susceptible to this if you leave a line blank on a restaurant credit receipt.

Shred, Shred, Shred - When you've reconciled your monthly billing statement, shred your receipts to prevent thieves from rifling through your trash to obtain your account information.

Whenever you are doing something around your home, think about the impact it will have on your neighbors. This is particularly important with regard to trash and construction projects. Please do not put your trash out before dusk the night before trash pick-up and be sure and take your bins and trash cans in the day of pick-up. Always secure your trash so that it does not blow around the neighborhood and do not put construction materials out for regular trash pick-up. You should ask the contractor doing the work to haul away the debris and/or arrange to take it directly to the dump. Please call the trash company for a special pick-up of large items, such as appliances, at 703-818-8222, and only put them out on the day the trash company advises you to do so. Never throw garbage, construction or yard debris in the storm drains or store it in the common area. If you see loose trash around the neighborhood, please pick it up, it is great exercise! Finally, if you see someone putting trash out early or improperly dumping, please advise a Board member and include their name, house number, time and location of the incident, as well as your name and address. The Board cannot take action unless it can specifically identify those who are violating our regulations. If we all work together, we can keep Leewood a clean and enjoyable place to live. Soliciting in Leewood – Not Tolerated –

I've had two complaints about door to door solicitors in the past week and now I see a post on the message board. 'Last week there was someone from an Orkin company who was going door to door to solicit business. He claimed "my neighbor" was having problems with ants and that I should sign up for service.'

Please be aware of this kind of pressure selling. Soliciting is prohibited in Leewood. This is private property and there are *no soliciting* signs posted at both entrances. Never feel pressured from any salesperson or company knocking on your door and always get several estimates before choosing a contractor. Anyone going door to door must have a license from the County of Fairfax and they are required to have it with them at all times.

From the Board: Communicating With US

The board accepts messages from any homeowner wanting to communicate with us. It is most thoroughly done at open forum, as that is the only time we can actually engage in dialog. All other submissions should be directed to the appropriate committee by either e-mail or US mail. Please sign your messages and add a phone number so we can contact you. Please do not leave notes or letters on porches, doors or railings. These are unreliable means of delivery and your request will probably go unanswered.

All submissions will be considered including positive suggestions and complaints. If you have a grievance about a resident not following one of our rules or behaving in a manner you think demands our attention, try talking to this person first to see if they are aware of any misdeed. That may be all it takes to resolve the issue.
